The salary and mileage of the staff person that provides the services through this grant was diagnosed with cancer. This led to less time out of the office to conduct assessments, and some time off from work. This resulted in funds that were not expended as it was not feasible to hire someone for this small window of time.

1. Provide a description that addresses the entire scope of the proposed project.

The four-county basically rural Continuum of Care has chosen Mid Florida Homeless Coalition as the Lead Agency for Coordinated Intake. The Continuum of Care has chosen the VI-SPDAT and SPDAT assessment tools for use in qualifying and scoring households for service. One fulltime Lead Navigator is to be paid through this project. The Lead Navigator and Coordinated Intake Committee encourage other organizations to have staff trained as Navigators. The Lead Navigator, trained as a trainer on the VI-SPDAT and SPDAT tools, will offer quarterly training sessions for organizational staff who are interested in learning how to conduct the VI-SPDAT assessment and becoming a Navigator. These trainings will be held in group settings in an effort to ensure that the tool is being used the same by all Navigators. The Lead Navigator will also hold an annual re-training for all Navigators to provide re-certifications. The Lead Navigator's main responsibility will be to travel throughout the CoC to meet with potential participants to conduct either a VI-SPDAT and/or a full SPDAT for anyone who is not able to access a public site. The Navigator will review all referrals through HMIS for housing assessments as well as voicemails for assessment received by Mid Florida Homeless Coalition. The Navigator will make every effort to reach potential participants to arrange a meeting that is convenient for the participant and safe for the Navigator. All participants will be asked for permission to have their data entered into HMIS. All participants will receive feedback on the assessment and whether they qualify for housing services, and they will be given resource information based on their needs. The Lead Navigator will upload the assessment data into HMIS as well as any other data provided by the participant that may be helpful in getting them housed; e.g., copy of birth certificate, identification, DD-214, history of homelessness, etc. The participant's name will then be entered into the By-Name-List. The Lead Navigator will work cohesively with other Mid Florida Homeless Coalition staff as Providers of Housing request referrals from the Coordinated Entry System. The Lead Navigator will monitor the By-Name-List and will remain in contact with those who are identified as chronically homeless and eligible for Permanent Supportive Housing. The Navigator will continue to work with these participants in assisting them in getting paperwork together that will be needed in proving their chronic status or to get them into housing. The Lead Navigator will participate in bi-monthly Coordinated Intake Committee meetings, which will include providing updates and outcomes, making recommendations to improve the process, as well as getting feedback from other Navigators and committee members.

The advertising strategy is sharing flyers with local organizations throughout the CoC to be posted (shelters, food pantries, financial assistance providers, Health Department, etc.) encouraging those without a home to call Mid Florida Homeless Coalition. Many of those who are homeless find transportation to be a barrier to services; thus, they communicate via phone. Information about the how the process works is distributed via email, social media, and at local meetings. The phone number is distributed via the Mid Florida Homeless Coalition Quick Resource Cards that are distributed throughout the CoC. Visits will be made to service providers that do not attend regular meetings to provide them with this information; e.g., hospital social workers, law enforcement, fire departments, etc. The two 2-1-1 providers have been instructed to refer all calls from the literally homeless to the Mid Florida Homeless Coalition. All organizations that do some type of outreach are given this information to pass along. The Lead Navigator also joins the CoC’s main outreach team as needed.

All persons who are literally homeless and are interested in obtaining permanent housing are invited to be assessed via a VI-SPDAT, and if based on the score, qualify for RRH or PSH, are further assessed using the SPDAT tool. The participant is then placed on the By-Name-List. All organizations that have HUD CoC PSH and RRH funded units, as well as any RRH funded units through Mid Florida Homeless Coalition (MFHC), are required to participate in Coordinated Intake. The Provider of HUD CoC PSH and RRH units contact Mid Florida Homeless Coalition via email when a unit becomes available. The PSH Provider with scattered-site units supply the number of bedrooms available with the open unit. The By-Name-List is searched based on the county where the Provider operates the PSH and RRH program. The person with the highest SPDAT score that is Chronically Homeless is contacted by the Lead Navigator to confirm that the person is still homeless, meets the Chronic definition, and is questioned about their desire for the housing that is available. Once confirmation of chronicity and a desire for the available housing, MFHC makes a referral via HMIS to the Provider. The highest SPDAT score for RRH or the lowest score for PSH are referred to the Provider via HMIS. RRH for ESG or State fund referrals are based on the SPDAT score.
