## 2B. Experience of Applicant, Subrecipient(s), and Other Partners

### 1. Describe the experience of the applicant and potential subrecipients (if any), in effectively utilizing federal funds and performing the activities proposed in the application, given funding and time limitations.

Catholic Charities, Diocese of St. Petersburg, Inc. (CCDOSP) has more than sixty (60) years of experience administering federal, state, and county funds and generating the required/associated monitoring and outcome/evaluation reports. The agency's long history of serving homeless individuals goes back to its founding years with some of the first federal funds awarded for the benefit of stranded refugees who essentially were homeless. For the past seventy (70) years, Catholic Charities has provided a broad array of social services designed to support and preserve families and promote self-sufficiency and social justice.

Today these services include: refugee and immigration services, family support, adoption services, pregnancy and parenting support, mobile medical services, homeless shelter services, housing for HIV/AIDS, disabilities, elderly and farm worker family housing and housing counseling. More than three decades of experience is directly related to providing qualified clients with rent and mortgage assistance services. Most recently this experience includes five years implementing, monitoring and evaluating EFSP funds in Hillsborough, Pinellas, and Pasco counties, ESG funds in Pinellas and Pasco Counties and HPRP funds in the City of St. Petersburg. Funds assisted clients who were homeless and/or at-risk for becoming homeless with rent, mortgage, and utility assistance. In FY2017/2018 Catholic Charities, Diocese of St. Petersburg, Inc. provided services to 14,821 persons throughout the agency's five-county service area.

Catholic Charities has been accredited since 2005 and we underwent accreditation in March 2015. In May 2015, we were advised by the Council on Accreditation (COA) that the agency passed the accreditation process for the third time. The final documentation from COA was approved through the year 2020. Council on Accreditation attests that our organization meets the highest national standards and is delivering the best quality services to the community it serves. CCDOSP is still proud to be a part of COA's Community of Excellence that includes more than 2,200 private and public organizations that serve over 7,000,000 children, individuals, and families in the United States and Canada.

Routinely, CCDOSP meets and/or exceeds grant outcomes before the end of the reporting period. Monitoring reports from federal and state funding agencies are positive with only an occasional minor corrective action required. This extensive experience administering federal funds to provide housing and related services clearly demonstrates the agency's management and staff capacity to achieve the goals and objectives set forth in this proposal.

**2. Describe the experience of the applicant and potential subrecipients (if any) in leveraging other Federal, State, local, and private sector funds.**

The FY 2017/2018 total agency operating budget was 17,108,939 million dollars. Revenue sources include federal, local state and government, United Way, Diocese of St. Petersburg, foundations, program fees and private donations. Fifty-eight (58) percent of the current budget is raised from grants, donations and Diocesan support. Forty-two (42) percent is from program fees and rental income. Some of the first federal funds were awarded for the benefit of stranded refugees.

More than three decades of experience is directly related to providing rent and mortgage assistance services. For the past five years Catholic Charities has effectively implemented, monitored and evaluated ESFP funds in Hillsborough, Pinellas and Pasco Counties and ESG funds in Pinellas and Pasco Counties and HPRP funds in the City of St. Petersburg. Catholic Charities has also managed State Challenge Grant funds to assist the homeless in obtaining permanent housing.

In 1998, CCDOSP purchased Mercy Apartments with HOPWA funding. Mercy Apartments provides permanent housing through four, two-bedroom apartments for families with an HIV/AIDS infected member. Renovations were funded through HOPWA and HUD SHP funds. In 2002, CCDOSP began providing emergency rent and utilities assistance to HIV infected persons funded with federal Ryan White dollars, and assumed the Hillsborough County funded Supportive Housing Assistance Program (SHAP) through the lease of 14 one and two-bedroom apartments in Tampa. In December 2002, CCDOSP began managing a permanent housing program consisting of 30 two-bedroom apartments for HIV/AIDS individuals and families which was converted to tenant-based rental assistance in fall 2004. In 2008-09, Catholic Charities was asked to administer a Hernando County TBRA program previously managed by another agency. This increased the number of vouchers from 40 to 75 representing a 48% increase over a two-year period thus providing individuals and families with stabilized housing opportunities in the greater Tampa Bay area.

Additionally, CCDOSP has 122 agricultural farm worker low-income housing units in the Dover community. The agency operates fourteen HUD 202s facilities. This extensive experience in administering federal funds and providing housing assistance and related services clearly demonstrates the agency's management and staff capacity to achieve the goals and objectives set forth in this proposal.

**3. Describe the basic organization and management structure of the applicant and subrecipients (if any). Include evidence of internal and external coordination and an adequate financial accounting system.**

A Board of Trustees composed of community volunteers representing the five county area governs Catholic Charities, Diocese of St. Petersburg, Inc. This Board is responsible for setting policy, approval of Strategic and Continuous Quality Improvement Plans and general oversight of all Catholic Charities' programs and corporate activities. The Finance Committee of the Board of Trustees provides oversight of the organizations' fiscal operations and client

information system.

Serving under Frank V. Murphy, III, President of the Board, Mark Dufva, appointed in 2014. Mr. Dufva began his career as Executive Director of Catholic Charities of Northwest Florida in 2004. Prior to taking over as Executive Director of Catholic Charities, Mark served as Executive Director of Youth Opportunity with the Tampa YMCA, a 5-year, \$24M US Department of Labor education and job training program. He spent seven years with the United Way in Tampa as Director of Community Services and was responsible for developing their outcome funding systems. He also spent five years with the Alliance for the Mentally Ill in Boston, MA and began his human service career as a Peace Corps Volunteer in the Philippines from 1984-1987. Under Mr. Dufva's direction a Senior Team of qualified Directors and Program Managers lead the numerous programs and support staff throughout the five counties.

Catholic Charities has a separate cost center and account number in our financial system to record the grant. The program staff interviews the clients and determines the eligibility of the client as stated in the guidelines of the grant. When eligibility is determined a check disbursement form is sent to the agency administrative offices for payment of the expenses. The disbursement is made and mailed directly to the landlord or utility company. The program is monitored by the Director. Financial recording is reviewed by the CFO and are presented to the Board of Trustees on a quarterly basis. An independent audit is completed annually. The audit includes an opinion on Catholic Charities financial statements and an assessment of the internal control structure, including compliance with federal grants.

### **3B. Project Description**

**1. Provide a description that addresses the entire scope of the proposed project.**

Catholic Charities proposed project will provide rental assistance in scattered sites throughout Hernando County for 6 families and Citrus County for 2 families with children experiencing homelessness. Members of these households may be with or without disabilities, and able to live independently in housing. Eligible households will be provided permanent housing quickly without spending long periods of time in shelter or transitional housing programs and achieve stability in permanent housing. Financial assistance will include short-term rental assistance for up to three months, medium term rental assistance for 4 to 12 months and utility deposits.

Catholic Charities will participate and accept clients referred to them through the Coordinated Intake and Assessment system. Once a household has been successfully screened and referred for appropriate program services they will be asked to come to Catholic Charities' site to meet with staff in person; an appointment time is provided. If the participant is unable to travel to Catholic Charities' site, case managers will have the ability to travel between programs for further assessments if needed. Thirty-day bus passes or one-day bus passes may be provided for travel on public transportation to eligible services such as medical care appointments, employment, and child care.

Intensive case management will include but will not be limited to assessment, developing an individualized service plan, including a path to permanent housing stability subsequent to the Rapid Re-Housing financial assistance. Coordinating access to services in the community to fulfill the service plan and on-going progress evaluation and follow up will take place with each participant.
